ECON 793: Economics of Labor

Guido Menzio University of Pennsylvania Spring 2018

Description: The course covers three topics at the intersection of labor and macro. In the first part of the course, we will focus on theories of workers' transitions between employment, unemployment, and across different employers and on the resulting cross-sectional wage distribution. In the second part of the course, we will study the behavior of workers' transitions across labor market states over the business cycle. In the last part of the course, we will turn to studying the right-tail of the distribution of labor earnings and wages. The lectures will mostly be about theory. Open discussions will be centered on empirical facts.
